The Florida Department of Transportation (FDOT), District Four, will conduct a public meeting regarding the improvement project at the SR-9/Interstate 95 SR-804/Boynton Beach Boulevard Interchange and along Boynton Beach Boulevard in the City of Boynton Beach in Palm Beach County. This public meeting will be offered in two different formats: virtual and in-person. The public meeting will have representatives available to answer questions. PROJECT PURPOSE

The goal of this project is to increase capacity at the SR 9 (I-95) interchange with SR 804 (Boynton Beach Boulevard), to improve its operations, and to enhance safety for all users.

PROJECT IMPROVEMENTS

- Widen each of the I-95 interchange ramps.
- Widen Boynton Beach Boulevard to include bicycle lanes and sidewalks (8 ft. minimum).
- Improve access for those with disabilities.
- Installation of signing and pavement marking, signalization, lighting, intelligent communications technology, and structures.

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the impacts of construction on the community.
- Occasional lane closures are anticipated during construction during non-peak hours.
- Driveway access will be maintained throughout construction.

CONSTRUCTION INFORMATION

• Construction Begins: Fall 2024

Anticipated Completion: Summer 2027
Construction Cost Estimate: \$39 million
